 - **A complaint has been lodged with CCC Planning by a local resident requesting urgent action to resolve the issues at the cross roads at Henllan Amgoed with regard to the dairy complex and access road to it**
 - **Application was first considered 30 March 2010 and no planning permission has been granted**
 - **HCC’s letter of concerns have come to fruition**

- **Lack of planning enforcement has lead to a slurry pollution and a new vehicle access becoming more dangerous with near misses to cars as junction and road not wide enough to support greatly increased load of traffic to and fro**
 - **Advised by CCC in June 2015 that Highways were to redesign the junction at the Applicant's cost are now not going to happen**
 - **HCC to support complainant by writing to CCC Planning and copying correspondence to M.P. and A.M.**
