# When you contact the Council

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable the Council to contact you, respond to your correspondence, provide information and/or access its facilities and services. Your personal information will be not shared or provided to any other third party.

## The Council's Right to Process Information

### **Information Security**
